# UNDERGRADUATE PROGRAMMES - Refund Policy on Withdrawal of Admission [UG 2025 Cohort]

The official Last Date of Admission is July 31, 2025.

#### Below are the Refund Details on Withdrawal of Admission:

Percentage of Refund of Fees*	Point of Time (Notice of Withdrawal Received)	Refund details
100%	15 days or more before July 31, 2025 (on or before July 16, 2025)	100% refund of the fees* paid less a 5% administrative processing fee (maximum INR 5,000).
90%	Less than 15 days before July 31, 2025 (July 17 - July 31, 2025)	90% refund of the fees* paid.
80%	15 days or less after July 31, 2025 (August 1 - August 15, 2025)	80% refund of the fees** paid.
50%	30 days or less, but more than 15 days after July 31, 2025 (August 16 - August 30, 2025)	50% refund of the fees** paid.
0%	More than 30 days after July 31, 2025 (on or after August 31, 2025)	None of the fees** paid will be refunded.

- The date of receipt of the online/written withdrawal request will be used for calculation.
- The above refund details are based on the amount(s) deposited by the candidate within the given payment deadlines of Plaksha University.
- The refund amount may vary for candidates who have received a Scholarship/financial aid.
- All refunds will be processed within 21 days from the date of submitting the "withdrawal application form".
- Plaksha University reserves the right to change, modify, add, or remove portions of the

- All refund requests will be made through the registered email address.
