**Roles and Responsibilities of the Committee:**

The Committee will be responsible for implementing and overseeing the Mental Health Policy for students and employees, including:

- Assigning dedicated mentors to student batches.
- Enforcing the prohibition of harmful practices like academic segregation and public shaming.
- Establishing and promoting referral protocols for mental health services.
- Organizing mandatory training sessions for staff on psychological first aid and inclusive engagement.
- Ensuring confidential redressal mechanisms for harassment, bullying, and assault.
- Conducting sensitization programs for parents and students
- Maintaining anonymized records and preparing an Annual Report for regulatory bodies.
- Promoting extracurricular activities and reviewing examination patterns to reduce stress.
- Ensuring the safety of residential environments and installing preventative safety devices where needed.

**Frequency, Tenure & Quorum of the Committee:**

- The tenure of the Committee shall be 1 year from the date of notification.
- The Committee shall meet once every fortnight.
- The quorum for meetings shall be two-thirds (2/3) of the total members.
