**Roles and Responsibilities:**

The Anti-Ragging Committee is responsible for ensuring a ragging-free environment on campus. Its key responsibilities include:

1. Designing strategies and action plans to prevent ragging through various initiatives.
2. Conducting awareness programs at regular intervals.

3. Ensuring compliance with regulations and laws related to anti-ragging.
4. Investigating complaints of ragging and taking appropriate action.
5. Overseeing the activities of the Anti-Ragging Squad to enhance prevention efforts.

#### **Tenure, Quorum, and Meeting Frequency**

1. **Tenure:** The term of the committee members shall be one year from the date of notification. Those student members who graduate from the program before the term ends shall be replaced by other student nominees.
2. **Quorum:** A minimum of five members must be present for the committee meeting to proceed.
3. **Meeting Frequency:** The committee shall meet as and when required, but at least once a year.
