## Functions of the Research Advisory Council (RAC):

- 1. To foster a research ecosystem at Plaksha University that produces reliable, impactful, and sustained research outputs.
- 2. To build an ecosystem for knowledge generation, research facilitation, collaboration, innovation, and technology development for industrial and societal benefit.



3. For effective governance (regulations and policies), the RAC may form subcommittees focused on research and development, innovation, collaboration, product development, and legal and ethical matters.

## 4. Tenure, Frequency & Quorum:

- a) The tenure of the council shall be two years.
- **b)** The council shall convene at least **three times per academic year** i.e., between July June every year.
- c) A quorum shall be constituted with a minimum of **two-thirds** (2/3) of the members present.
- d) The RAC shall submit detailed **progress reports** to the Academic Council.
